enriches our portfolio with an impressive customer base and high-quality services. In addition, Stampfli will enable us to significantly expand our presence in Switzerland and strengthen our joint network - all on the basis of strong values. Above all, our customers will benefit from this."

"This step is a great opportunity for all Stampfli employees to develop successfully within the company and to contribute to its success in exciting fields of work," emphasizes Simon Stampfli.

There will be no immediate changes for customers or employees of either company. Simon Stampfli, owner and managing director of Stampfli AG, will leave the company with effect from May 2025 and hand over operational management to WISAG Switzerland.
